

**REQUIRED REPORTING OF INFORMATION**  
**Posted March 1<sup>st</sup>, 2024**

To do and perform all things requisite, necessary or desirable within district boundaries to comply with the requirements and conditions imposed on "local interests," by the Congress of the United States of America, in its Rivers and Harbors Act approved March 2, 1945, as said act has been and may be from time to time amended, authorizing the improvement and construction, under the direction of the Secretary of the Army and supervision of the Chief of Engineers, of an inland waterway in accordance with report submitted by letter of Secretary of War, dated June 22, 1939, Document No. 371, House of Representatives, 76th Congress, 1st Session, entitled "Intracoastal Waterway from Caloosahatchee River to Withlacoochee River, Florida," and all reports subsequent thereto relating to any change, modification, or expansion of said initial report. (Excerpt from Section 5 of WCIND's codified special act - Chapter 98-526, Laws of Florida (1998).

West Coast Inland Navigation District (WCIND) was created by a special act of The Florida Legislature, Chapter 23770, Laws of Florida (1947). The date that WCIND was established or created is May 26, 1947, the effective date of that special act.

7. A description of the boundaries or service area of, and the services provided by, the special district.

The District boundaries are the Counties of Lee, Charlotte, Sarasota and Manatee.

The services provided by WCIND include the following:

The District is empowered and authorized to operate and maintain that portion of the intracoastal waterway running through the District, and any other public navigation channels authorized by the Board of Trustees of the Internal Improvement Trust Fund; the District may undertake programs intended to alleviate the problems associated with its waterways; the District may sponsor or furnish assistance and support member counties and local governments within the district in planning and carrying out public navigation, local and regional anchorage management, beach renourishment, public recreation, inlet management, environmental education and boating safety projects directly related to its waterways; the District is authorized to participate in research, study or test programs as to the impact, both physical and biological, of waterway construction, maintenance and operation, including but not limited to erosion, accretion, and marine and shoreline vegetation; the District is authorized to sponsor or participate in environmental restoration and enhancement projects; the District is authorized to create advisory bodies and to assist local governments in the development of county and multi-county anchorage management programs.

8. A listing of all taxes, fees, assessments, or charges imposed and collected by the special district, including the rates or amounts for the fiscal year and the statutory authority for the levy of the tax, fee, assessment or charge.

The District may annually assess and levy against the taxable property in the District a tax not to exceed 0.2 mill on the dollar of assessed valuation for each year, and the proceeds from such tax are used by the WCIND Board for all expenses of the District.

The statutory authority for the levy of this tax is Section 12 of WCIND's codified special act – Chapter 98-526, Laws of Florida (1998). Full text of the Act on separate page under "Required Information" tab.

The 2023-2024 final millage rate is 0.0394 mill.
